

- In 2012, the Parks and Recreation Commission gathered information from Malibu residents and stakeholders in the community on opinions on parks, facilities and program needs.
- As a lot of things may have changed since the last survey that was done over a decade ago, the City has developed an innovative outreach program designed to engage a diverse cross-section of the community.

## **Overall Timeline**



- November 2016: "Trancas" lot was acquired by the City.
- April 2018: "Heathercliff", "Chili Cook-Off" and "Triangle" lots were acquired by the City.
- November 2018: Woolsey Fire swept through Malibu.
- February 2020: "La Paz" lot dedicated to the City.
- March 2020: COVID-19 Pandemic



## **Outreach Program Goals**




The goal of this initiative is to facilitate meaningful dialogue among community members to ensure the future use of these lands aligns with the long-term needs and aspirations of the entire Malibu community.



## **Project Timeline**

- We are currently in Phase 1 to collect initial feedback on the types of uses the community prefers
- In Phase 2, we will be looking for more narrow feedback and specifics for each community land







- After Phase 2 is complete, the City and Council will assess the best uses for these five parcels of land.
- Once decided, the City will have to get approval from the City and California Coastal Commission.
  - A complete application can take anywhere up to 6 to 11 months.
  - If appealed, the process can be delayed up to another 6 months.


# Group Discussion and Q&A
